Chairperson's Report by Salvatore Galletta, P.E. - Chairperson

As I write this report the year has just come to an end. The end of the year is usually a time for reflection and assessment. As we look back on the year 2004 we, as an organization, can take stock of our accomplishments, setbacks and disappointments. I will try to briefly summarize some of the major activities AEA has undertaken during the past year. One of the key initiatives that AEA has been vigorously pursuing is the implementation of the "Infrastructure Proposal" for the City of New York. As I explained in previous reports, the "Infrastructure Proposal" calls for creating a position of Deputy Mayor for Infrastructure for the City of New York. This proposal was introduced several years ago during the New York City mayoral race. We have been promoting it ever since. During the past several years we have been building support for the proposal within Engineering Community as well as with the political establishment. As you can well imagine this is a huge undertaking. After much effort we have finally come to the point where legislation will be drafted in the next couple of months and introduced in the New York City Council. In conjunction with this proposed legislation we are working with City Council members and various stakeholders to reintroduce the Qualifications Based Selection (QBS) bill in City Council. The QBS bill will eventually be incorporated into the "Infrastructure Proposal" legislation. However, to ensure its quick adoption, the QBS bill will be introduced in City Council as a stand-alone legislation. I am hopeful that our constant and focused efforts will yield positive results in the not too distant future.

In other areas, AEA has worked assiduously to educate our colleagues on the H1B Visa issue and the whole offshore outsourcing controversy. As a member of the Metropolitan Engineering Societies Council (MESC), which represents 23 Engineering Societies in the New York Metropolitan region, AEA has been at the forefront by informing our colleagues in the Engineering Community of the dire consequences of these issues if we do not take appropriate actions. Several of AEA Board members are tied to an informal, yet effective, national network of activists on these critical issues. Because of this network, we are kept up-to-date on the latest developments and we respond to events as they happen. Thanks to the many dedicated colleagues on the frontlines of the immigration issue, the Engineering Community is slowly responding to the challenges that H1B Visa, offshore outsourcing and the globalization forces pose for the Engineering Profession. Despite limited resources, AEA has been instrumental in disseminating information and mobilizing our colleagues to take action. We intend to continue and augment our efforts.

There are many other actions and activities that the Board

undertakes during the year, from writing letters to government officials, coordinating efforts with other Engineering societies to making presentations at schools and colleges. Although in themselves, each of these activities is not of major importance, cumulatively they are having an impact. The frustrating part is that AEA does not have the resources to mount major initiatives that would have a dramatic impact. That is why we need to grow the membership base and find other ways to raise funds for AEA. Only with enough resources can we hope to achieve our goals in a reasonable amount of time.

In an effort to make AEA more responsible and effective, the Board has revamped its administrative functions. We are in the process of updating our membership database. Soon you will be receiving correspondence from our Membership Committee chair, Verghese Menachery, PE, regarding your membership. Please respond to his request in a timely fashion. If your membership is in arrears, please arrange to bring it up-to-date. I thank you in advance for your cooperation. AEA needs your support.

This year's AEA Annual Meeting, Social and Award Presentation will be held on May 5, 2005 at Bayard's in lower Manhattan. This is a special year since it marks the 10th anniversary of the founding of AEA. Preparations for the event are underway. We intend to make it bigger and better than last year's event, which was a great success. Our guest speaker will be our distinguished colleague, Frank Lombardi, PE, Chief Engineer of the Port Authority of NY and NJ. He will be speaking on the Port Authority's Capital Program. In his presentation he will also discuss Engineering leadership in the context of delivering Engineering services as well as the / trend to commoditize Engineering services and what needs to be done to counteract it. As part of the evening festivities, we will be honoring some of our colleagues who have made significant contributions in promoting and advancing the Engineering Profession. If you know someone who deserves to be recognized for his or her contributions, please mail the name and reason for recognition to the Board. The categories of the various awards are given in this issue.

Please mark your calendar and let us celebrate together on this festive occasion.
